Overview

- * Record data such as telephone numbers, email, and business addresses etc for business contact only.

- Ensure data is collected and stored in two ways only
 - 1. email software e.g. outlook.
 - 2. business contact management software.
- Ensure the security of your data via our firewall and antivirus software including any contact detail available through our Website Client Portal
- Ensure your data is backed up along with our normal data back up in a secure UK location or cloud services.
- in the event of a breach or hostile intervention we will secure our server and notify you. General Reef Water Solutions in general do not sell direct to the public, and as such our contacts are primarily business to business only, and as such any contact with us is with the understanding that both parties are complicit with DPA 2018 protocols.

Your Rights as a data subject

- 1. **The right to be informed** This means we must inform you how we are going to use your data. We will do this through this policy and by informing you how your data will be used each time we collect it.
